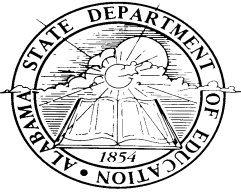

- Hold at least one parent/teacher conference to be held on October 14th (i.e. Open House or the system-wide scheduled Parent/Teacher Conference Day) in which this compact will be discussed as it relates to the individual child's achievement.
- Discuss and review the compact at each parent/teacher conference.

Provide parents with frequent reports on their children's progress.

- Provide information about the student's progress and school activities through weekly newsletters, bulletins, school website and progress reports every 4.5 week and 9 weeks. Parents will receive nine weeks reports on October 21, 2019; January 13, 2020; March 16, 2020; and May 21, 2020.

Provide parents reasonable access to staff.

- Provide parents reasonable access to staff (i.e. parent conferences) before school, during planning time or after school. Conferences can be initiated by the teacher, parent, student, or school administration by appointment.

Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

- Encourage parental engagement in education through various school sponsored workshops; opportunities to volunteer, classroom observations, or assistance with class events at times that are convenient to parents and teachers.

Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.

- Provide monthly calendar of events, workshops, and parent and family engagement opportunities.
- Provide daily and/or weekly updates on social media sites such as Facebook, Instagram, Twitter, Remind 101, and the EPS website.
- Conferences in a language the family member understands using an interpreter or the Language Line.
- Personal contact through phone calls and emails in a language the family member understands.
